

RESOLUTION

WHEREAS, the North Bergen Parking Authority currently obtains vehicle maintenance and repair services through an interlocal agreement with the Township of North Bergen; and

WHEREAS, since repair of the Township's emergency vehicles takes priority over nonemergency vehicles, at times causing a delay in return of the Authority's vehicles, the Commissioners desire to obtain additional vehicle maintenance and repair services to supplement the services provided through the interlocal agreement, permitting the Authority to place its vehicles in service more quickly; and

WHEREAS, pursuant to the Local Public Contracts Law, the Authority is required to obtain two written price quotes for said services; and

WHEREAS, the Authority has obtained three written quotes for said services, as follows: Fett Motors Auto and Truck Repair, with an hourly labor rate of \$65.00, a parts cost discount of 10%, Standard Oil Change cost of \$26.00 and Synthetic Oil Change of \$40.00; Cottage Auto Repair, with an hourly labor rate of \$60.00, a parts cost discount of 10%, Standard Oil Change cost of \$35.00 and Synthetic Oil Change of \$60.00; and Ajays Corporation, with an hourly labor rate of \$75.00, a parts cost discount of 10%, Standard Oil Change cost of \$36.95 and Synthetic Oil Change of \$52.95; and

WHEREAS, the Authority desires to utilize the services of two repair companies, in order to expeditiously have its vehicles placed into service, and Fett Motors Auto and Truck Repair, and Cottage Auto Repair having submitted price quotes which are most advantageous to the Authority, price and other factors considered, the Commissioners of the Parking Authority desire to obtain vehicle maintenance and repair services from Fett Motors Auto and Truck Repair, and Cottage Auto Repair,

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the North Bergen Parking Authority, that the Chairman of the North Bergen Parking Authority, is hereby authorized to enter into an Agreement, as approved by the attorney for the Parking Authority, with Fett Motors Auto and Truck Repair, and Cottage Auto Repair, in accordance with their quotes, subject to availability of funds, in a sum not to exceed \$15,000.00, per company, for vehicle maintenance and repair services; and




