

**RESOLUTION**

**WHEREAS**, the Parking Authority of the Township of North Bergen leases the parking lot located at 2123 Kennedy Boulevard, from the North Bergen Free Public Library (hereinafter, Library Lot), to utilize same as a parking lot restricted to use by residents of the Township of North Bergen; and

**WHEREAS**, the Parking Authority currently rents seven spaces to residents, 24 hours a day seven days a week; and

**WHEREAS**, the Parking Authority desires to rent the remaining 7 spaces to residents, overnight between the hours of 9 p.m. to 8 a.m. and all day on Sunday,

**NOW THEREFORE, BE IT RESOLVED** by the Commissioners of the Parking Authority of the Township of North Bergen, that the Parking Authority shall rent 7 additional spaces to residents of the Township, overnight between the hours of 9 p.m. to 8 a.m. and all day on Sunday, at the rate of \$50.00 per month, payable quarterly; and


