

**RESOLUTION**

**NO.: 0-961**

**WHEREAS**, the Commissioners of the North Bergen Parking Authority recognize the need to regulate the parking of vehicles within designated lines, where such are provided, in order to increase the number of available on-street parking spaces,

**NOW, THEREFORE, BE IT RESOLVED** by the Commissioners of the North Bergen Parking Authority that a recommendation be sent to the Mayor and Commissioners of the Township of North Bergen for the adoption of an ordinance making it unlawful for owners or operators of any motor vehicle to park said motor vehicle outside the painted lines which mark out the regulated parking space on the streets and in all Parking Authority parking lots. No owner or operator shall park or stand a motor vehicle so as to block or impede the progress of any other vehicle, or access by another vehicle to a vacant parking space, or exit from a parking space occupied by another motor vehicle; and

**BE IT FURTHER RESOLVED** that a fine of \$40.00 be recommended to the Mayor and Commissioners, for violation of this proposed ordinance, and that the Parking Authority of the Township of North Bergen receive from the Township of North Bergen the sum of \$15.00 for each summons written by parking enforcement officers, and said fine collected by the Township, for violation of this Ordinance; and

**BE IT FURTHER RESOLVED** that the attorney for the Parking Authority be and is hereby authorized to notify the Mayor and Commissioners of the Township of North Bergen of this recommendation and to prepare a proposed Amendment to the Township's Ordinance to accomplish same; and


