WHEREAS, the North Bergen Parking Authority desires to construct a fence to enclose the parking lot to be constructed at 1130-34 51st Street; and

WHEREAS, pursuant to the Local Public Contracts Law, the Authority is required to obtain two written price quotes for said services; and

WHEREAS, the Authority has obtained three written quotes for said services, as follows: Artistic Fence, in the sum of \$16,932; Galaxy Fence Co., Inc., in the sum of \$19,508; and Bergen Fence, in the sum of \$20,960; and

WHEREAS, Artistic Fence, having submitted the price quote which is most advantageous to the Authority, price and other factors considered, the Commissioners of the Parking Authority desire to obtain the services of Artistic Fence to construct a fence at 1130-34 51st Street,

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the North Bergen Parking Authority, that the Chairman of the North Bergen Parking Authority, is hereby authorized to enter into an Agreement, as approved by the attorney for the Parking Authority, with Artistic Fence, in accordance with its quote, which is incorporated herein by reference, subject to certification as to the availability of funds, in a sum not to exceed \$16,932.00, for construction of a fence at 1130-34 51st Street; and


