

**RESOLUTION
NO.: 0-983**

WHEREAS, pursuant to NJSA 40:11A-6 the North Bergen Parking Authority is authorized to provide off-street parking and to maintain and operate parking facilities under its control; and

WHEREAS, the Township has provided to the Parking Authority eight (8) parking spaces, located on the north side of 28th Street, at 1402-04 -28th Street, to operate as an off-street parking lot; and

WHEREAS, the Parking Authority desires to add two new spaces to said parking lot, bringing the total number of parking spaces, at said location, to ten (10), and

WHEREAS, the Authority desires to permit rental of spaces to resident owners of commercial vehicles, not to exceed two (2) spaces,

NOW THEREFORE, BE IT RESOLVED by the Commissioners of the North Bergen Parking Authority, that the Parking Authority shall operate and maintain ten (10) spaces, located on the north side of 28th Street, at 1402-04 -28th Street, which spaces shall be rented to residents for the sum of \$50.00 per month;

BE IT FURTHER RESOLVED that the Parking Authority shall also rent spaces in the 28th Street lot to residents of the Township with commercial vehicles, at a rental fee of \$100.00 per month, subject to the corresponding size restrictions of the parking space; and

BE IT FURTHER RESOLVED, that rents are payable quarterly, in the sum of \$150.00 for non-commercial vehicles and \$300.00 for commercial vehicles, the 1st day of the month beginning the quarter, as follows: January 1st, April 1st, July 1st and October 1st. Any person whose payment is received after the due date, shall be subject to an administrative fee of \$25.00; and
